However, in addition to recovering the legal charges from the other party most solicitors will then charge their own client a "success fee" of anything up to 25% of the compensation recovered. There could also be an additional payment for an insurance premium.

Whether you win or lose your claim, we guarantee you will pay nothing for our services and retain 100% of the compensation we recover on your behalf. You will not need to pay us a success fee or an insurance premium.
